Open Records Act Research Policy Pursuant to C.R.S. Section 24-72-205(6), upon receipt of an request under the Open Records Act requiring research, the town clerk will

estimate the research time and the number of photocopies required to comply with the request. The requester must pay the estimated research fee prior to commencement of the research. Upon research completion, any excess fee collected will be refunded to the requester. If the town clerk underestimated the fee, the requester must remit the unpaid balance prior to release of the research results. The research fee is \$0.00 for the first hour and \$30.00 per hour for each additional hour. The charge for each photocopied page is twenty-five cents (\$0.25).
