

**RESOLUTION NO. 1013-17**

**A RESOLUTION ADOPTING THE 2018 BUDGET AND APPROPRIATING SUMS OF MONEY FOR THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNTS AND FOR THE PURPOSES SET FORTH BELOW, FOR THE TOWN OF FOWLER, COLORADO, FOR THE 2018 BUDGET YEAR.**

**WHEREAS**, C.R.S. §29-1-108(2) requires local governments to adopt an annual budget and make appropriations for the budget year; and

**WHEREAS**, the Board of Trustees of the Town of Fowler desire to adopt a budget for the 2018 budget year; and

**WHEREAS**, the Board of Trustees of the Town of Fowler desires to appropriate sums of money for the various funds for budget year 2018.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Town of Fowler as follows.

1. The Board of Trustees having published notice of a budget hearing and having conducted said budget hearing pursuant to C.R.S. §29-1-106 and having considered all public comments on the budget hereby adopts the budget for budget year 2018 attached to this resolution, labeled as Exhibit "A" and incorporated in this resolution as though fully set forth herein.
2. The following sums are hereby appropriated from the revenue of each fund or spending agency for budget year 2018 as set forth below.
