

RESOLUTION NO. 969-16

A RESOLUTION ESTABLISHING GUIDELINES FOR EXERCISE ROOM USE

WHEREAS, the Fowler Police Department has obtained exercise equipment; and

WHEREAS, the equipment has been installed in the old town hall located on U.S. 50 to allow police officers to exercise; and

WHEREAS, the police department wishes to make the facility available to town employees, elected officials, and volunteer firemen as well as their various families; and

WHEREAS, it is necessary to establish basic guidelines for the use of the facility.

NOW THEREFORE, BE IT RESOLVED by the Town of Fowler Board of Trustees as follows.

1. Any person using the exercise facility assumes the risks of using the equipment; the facility shall be posted informing all users of this policy.
2. No person shall use the facility until the proper operation of the equipment in the facility and risks of using the equipment has been explained to the person, and person signs a document indicating the person has received this information.
3. Instructions on how to use each piece of equipment shall be placed on the equipment or adjacent to it so the user can review proper use of the equipment as needed.
4. The following persons are allowed to use the facility subject to the conditions set forth in this resolution:
 - a. Town of Fowler employees and family members residing in the employee's residence who are 14 years of age or older;
 - b. Town of Fowler elected officials and family members residing in the volunteer's residence who are 14 years of age or older;
 - c. Fowler Rural Fire Protection District volunteers and family members residing in the volunteer's residence who are 14 years of age or older;
 - d. Fowler Rural Fire Protection District elected officials and family members residing in the volunteer's residence who are 14 years of age or older.
 - e. Each family allowed to use the facility may bring up to two guests so long as the guest comply with all conditions set forth in this resolution and the family that brings the guests remains responsible for the actions of the guests at all times the guests are present.
5. Fees. The following fee structure is adopted by the Board of Trustees. No person shall use the facility unless the proper fees have been paid.

a. Initiation Fee

i. One Time Initiation Fee:\$20.00 per family.

b. Monthly Use Fees

i. First individual user per family.....\$10.00 per month

ii. Spouse\$5.00 per month

iii. Per child 14-18 years of age.....\$2.00 per month

iv. Per child 19 or older living in household.....\$5.00 per month

c. Daily Guest Fee

i. Per family guest\$5.00 per day

6. All fees will be paid to the treasurer and reserved to offset expenses related to the facility, the equipment and facility supervision that may be required from time to time.
7. The administration shall work with the police department to develop a means of access that will facilitate the safety of those using the facility.
8. The administration shall assure that panic bars are installed on access doors on the north and south sides of the building prior to opening the facility for use.
